In 2021 UAB "Padvaiskas ir ko" has started to implement the project "Digitisation of Manufacture". With this project the company aims to partly digitise the company's manufacture processes and thus create conditions for the growth of productivity. To achieve the goal of this project a set of equipment with digital technology will be purchased and installed.

The project will be implemented in accordance with the 2014-2020 Lithuania's European Union Funds Investment Operational Programme, third priority category "Promotion of Small and Medium Business Competitiveness" measure "Industrial Digitisation LT" (03.3.1-LVPA-K-854).

The amount of EUR 1,056,930 was allocated from the European Regional Development Fund for the implementation of the project. This amount will cover 35% of the project costs and thus make a strong contribution to the company's ability to achieve project objectives.

The project is planned to be implemented by March 16, 2023.

In 2020, UAB Padvaiskas ir ko began implementing the project “Implementation of Renewable Energy Resources in UAB Padvaiskas ir ko”. The aim of this project is to reduce the intensity of the company’s energy consumption by increasing RES production and consumption. In order to achieve the project’s goal, renewable energy equipment (solar photovoltaic power plant) will be purchased and installed, reducing the company’s energy intensity.

The project will be implemented in accordance with the priority 4 “Promoting Energy Efficiency and the Production and use of Renewable Energy” measure “Renewable Energy Sources for the LT+ Industry” (04.2.1-LVPA-K-836) of the Lithuanian European Union Funds Investment Operational Program for 2014-2020.

An amount of EUR 91257.06 was allocated from the European Regional Development Fund for the implementation of the project. This amount will cover 50 percent of the project costs, making a strong contribution to the company’s ability to achieve these project objectives.

The project is planned to be implemented by 15 March 2022.
